DISTRICT DEVELOPMENT MODEL

TERMS OF REFERENCE FOR PARTNERS PARTICIPATING IN THE DISTRICT DEVELOPMENT PLANNING FORUM (DDPF)

1. Background:

The District Development Model (DDM) is a collaborative approach that brings together various stakeholders to promote integrated and coordinated development at the district level. As partners in the DDM, it is essential to adhere to the following terms of reference to ensure effective and efficient collaboration.

2. Objectives:

The primary objectives of the DDM partnership are as follows:

6. Duration and Review:
